PROFIT WARNING

This announcement is made by Allan International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary review of the unaudited consolidated management accounts of the Group for the six months ended 30 September 2022 and the information currently available to the Board, the Group is expected to record a net loss within the range of HK\$19 million to HK\$22 million (before impairment of property, plant and equipment and right-of-use assets, if any) as compared to a net profit of HK\$9.4 million recorded by the Group for the six months ended 30 September 2021. The expected loss was mainly due to:

- (a) the drastic decrease of approximately 45% in sales turnover due to weak demand and customer sentiments. The decrease was most severe in the European market due to high inflation, increase in energy costs and geopolitical issues surrounding the Russia-Ukraine conflict
- (b) decrease in gross profit margin due to
 - increase in material costs, particularly electronic components with shortage in supply
 - high staff cost level as a percentage to revenue
- (c) the fair value gain of investment properties for the six months ended 30 September 2022 was approximately HK\$1.5 million as compared to approximately HK\$14 million for the same period last year.

In view of the adverse global business environment and loss situation of the Group, there is indication for impairment of property, plant and equipment and right-of-use assets of the Group. The expected net loss mentioned above have not included such impairment. The impairment assessment is currently being conducted and under review.

The Company is still in the course of finalizing its consolidated financial results of the Group for the six months ended 30 September 2022. The information contained in this announcement is only a preliminary assessment by the Board based on the information currently available to the Board, which have not been audited or reviewed by the Company's auditor nor reviewed by the audit committee of the Company, and may be subject to amendments. The Group's interim results for the six months ended 30 September 2022 are expected to be published on 30 November 2022.

Shareholders and potential investors are advised to exercise caution in dealing in the shares of the Company.
